We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2014-15 educational progress for the University Prep Science & Math High School. The data in our Annual Education Report shows that we have challenges in English and Math in grade eleven. We adopted the Engage NY that is aligned with the common core to support Math and English. We have an Instructional Coach to support teachers in their academic content areas with an emphasis on rigor and instructional best practices. This support encompasses one-on-one time with the teacher, support with lesson plans and real-time coaching in the classroom. To address the challenges in English, select students were assigned an ACT Prep class that addressed areas of ELA. Students were also given after school ACT Prep classes that addressed the area of Math. After School tutoring is continually offered to all students daily and is free for each student. Students at University Prep Science & Math High School have access to Kahn Academy that serves as a resource and tutoring site for Math. Students PSAT scores are directly link to Kahn Academy and each student's lesson tailored to their individual area of improvement. Additionally, data dialogue is ongoing and we continue to identify the gaps in achievement and make the necessary adjustments needed to improve student success.
